ORDER

ON CALCULATION OF CHARGES FOR THE MINIMUM ACCESS PACKAGE AND ON CALCULATION OF CHARGES FOR USING PUBLIC RAILWAY INFRASTRUCTURE TO PROVIDE TRANSIT RAIL TRANSPORT SERVICES WITHIN THE PERIOD OF VALIDITY OF THE ANCILLARY TIMETABLE FOR THE YEARS 2025 – 2026

1. The charges for the minimum access package within the period of validity of the ancillary timetable for the years 2025 – 2026 as follows:

- 1.1. train traffic charge rate – 0.0013 €/tkm gross;
- 1.2. charge rate for the carriage of cargo from or to third countries operated on the 1,520 mm gauge railway network – 0.0111 €/tkm net;
- 1.3. charge rate for the carriage of goods assigned to the railway transport sector, which may be subject to mark-up (hereinafter – segment) on local route:
 - 1.3.1. coal and coke goods transportation on a local route charge rate – 0.0025 €/tkm net;
 - 1.3.2. metals and minerals goods transportation on a local route charge rate – 0.0043 €/tkm net;
 - 1.3.3. gasoline and other fuel goods transportation on a local route charge rate – 0.0191 €/tkm net;
 - 1.3.4. chemical goods transportation on a local route charge rate – 0.0108 €/tkm net;
 - 1.3.5. multimodal transport goods transport on a local route charge rate – 0.0000 €/tkm net;
 - 1.3.6. consumer goods and industrial goods transportation on a local route charge rate – 0.0059 €/tkm net;
 - 1.3.7 agricultural goods transportation on a local route charge rate – 0.0070 €/tkm net;
 - 1.3.8. other cargo transportation on a local route charge rate – 0.0000 €/tkm net;
- 1.4. charge for the carriage of goods assigned to the segment on EU route:
 - 1.4.1. coal and coke goods transportation on a local route charge rate – 0.0016 €/tkm net;
 - 1.4.2. metals and minerals goods transportation on a local route charge rate – 0.0024 €/tkm net;
 - 1.4.3. gasoline and other fuel goods transportation on a local route charge rate – 0.0189 €/tkm net;
 - 1.4.4. chemical goods transportation on a local route charge rate – 0.0127 €/tkm net
 - 1.4.5. multimodal transport goods transport on a local route charge rate – 0.0000 €/tkm net
 - 1.4.6. consumer goods and industrial goods transportation on a local route charge rate – 0.0065 €/tkm net;
 - 1.4.7 agricultural goods transportation on a local route charge rate – 0.0022 €/tkm net;
 - 1.4.8. other cargo transportation on a local route charge rate – 0.0000 €/tkm net;
- 1.5. charge for the use of contact grid – 0.2334 €/train km

2. The charges for using public railway infrastructure to provide transit rail transport services within the period of validity of the ancillary timetable for the years 2025 – 2026 as follows:

- 2.1. passenger, baggage transit charge rate – 0.0138 €/tkm gross;
 - 2.2. cargo transit charge rate – 0.0267 €/tkm net;
